

**BANFIELD CLIENT EXPERIENCE SWEEPSTAKES
OFFICIAL RULES**

*NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.*

1. **ELIGIBILITY:** Open to legal residents of the 50 United States and the District of Columbia (“U.S.”) who are 18 years of age or older at time of entry. Employees, officers and directors of Medical Management International, Inc. (“Banfield” or the “Sponsor”), any Banfield pet hospital, the Banfield Charitable Trust, their respective parent companies, affiliates (including PetSmart, Inc.), and subsidiaries, Sponsor’s advertising and promotion agencies, and the immediate family members (spouses, siblings, children, parents, grandparents, grandchildren and spouses of the foregoing, regardless of where they live) or members of the same households (whether related or not) of such individuals are not eligible. Subject to all applicable federal, state and local laws and regulations. Void where prohibited.
2. **TO ENTER:** The Banfield Client Experience Sweepstakes (the “Sweepstakes”) begins at 12:01 AM Central Time (“CT”) on February 16, 2019 and ends at 11:59 PM CT on February 15, 2020 (the “Sweepstakes Period”), and consists of four “Entry Periods”, as follows:

Enter online: Access the survey entry page via the website printed on invoices distributed at participating Banfield pet hospitals during the Sweepstakes Period. You will be asked to respond to several questions regarding your most recent experience at Banfield, and to provide the survey code printed on the invoice and all other information requested. Online entries must be received by Sponsor by 11:59 PM CT on the last day of an Entry Period to be entered in the Sweepstakes and to be eligible for the random drawing applicable to that Entry Period.

Enter by mail: Hand print your name, complete address, telephone number and age on a piece of paper, place it in an envelope, and mail to: Banfield Client Experience Sweepstakes, PMI Station, PO Box 3577, Southbury, CT 06488-3577. Mail-in entries must be postmarked by the last day of an Entry Period and received by Sponsor no later than the eighth day following the close of an Entry period to be entered in the Sweepstakes.

There is no limit to the number of times you may enter online or by mail. However, each online entry must have a different survey code, and each mail-in entry must be mailed on a separate post card.

3. **RANDOM DRAWINGS:** Random drawings will be conducted on the dates listed in Section 2. Entries for any given Entry Period will not be entered or otherwise included in any other Entry Period’s drawing.
4. **PRIZES/ODDS OF WINNING:** Promotion Mechanics, Inc., an independent judging organization (the “Administrator”), will conduct a random drawing from among all eligible entries received for the specified Entry Period to award one (1) prize consisting of \$2,000 cash to be awarded in the form of a check. The potential winners will be notified by telephone and/or email and will be required to complete an affidavit of eligibility, liability and (where legal) publicity release which must be returned within the time period specified in the notification letter.
